



## **JUNIPER JAM 2019**

### **ART/ARTIST VENDOR AGREEMENT**

#### **DISPLAY:**

The fee for each ART/ARTIST VENDOR set up at JUNIPER JAM 2019 is **\$25**. This fee is payable to the WALLOWA VALLEY MUSIC ALLIANCE within FIVE (5) days of the completion of the Festival. (All Vendor payment due no later than September 7<sup>th</sup>, 2019.)

2. Limited electrical hook up is available. Please bring adequate (heavy & strong) extension cords. Tables and tents will NOT be provided. All equipment and supplies must be self-provided. The JUNIPER JAM Festival committee must approve any/all unusual equipment.
3. Bring your own lights. Extra lighting may be needed to enhance your display especially as the sun goes down and natural light is limited.
4. Wallowa Valley Music Alliance requests that all ART/ARTIST VENDORS remain on display throughout the Festival. You may close your booth when last performers take the Main Stage at approximately 8:00pm but no tear down of any booth is allowed until the Festival closes and the last performers are off the Main Stage.
5. General Festival Security is available but NO SECURITY will be available for individual vendor booths. You are responsible for all sales and all security of any of your art on display at all times during the Festival. You are responsible for loading and unloading your equipment and displays. You are responsible for clearing all trash in your area after the conclusion of the Festival.
6. All vehicles must be out of the Festival area by 10:00am on Saturday morning, August 31, 2019.
7. After the conclusion of the Festival, vehicle traffic in and out of the park cannot be permitted until ALL PEDESTRIAN TRAFFIC IS CLEAR and vehicle traffic is approved by Security.

#### **SET UP/TEAR DOWN**

Vendors will be required to be set up and ready for display and sales by 10:30 am on Saturday, August 31, 2019. The gates will open at 9:00am for set up on Saturday, August 31, 2019 to accommodate the Vendors. Festival main gates open to the Public at 11am and all Art/ARTIST Vendors need to have displays ready no later than 10:30 am on Saturday, August 31, 2019. Vendors may also set up on Friday afternoon if arranged with festival director.

#### **VENDOR GATE PASSES**

All Vendors will be provided with a MAXIMUM of FOUR (4) VENDOR PASSES to enter the park. Vendors will need to make arrangements to exchange passes between workers at the front gate to cover any shift changes. If any Vendor anticipates more than FOUR (4) workers at any one time then special arrangements must be made with the Festival committee PRIOR to Friday, Aug. 30, 2019.
